# Why doing research?

Duty: teaching, researching, academic service, cultural activities.

- Pressure for continuing research:
  - Ph.D. is not enough.
  - Promotion opportunity, not only Ph.D., but also Assistant Professor, Associate Professor, and Professor.
  - Minimum requirement on academic positions set by university and Min of Education.
  - Getting ready for a soon-coming of “autonomous university” completion for all universities in Thailand.
  - Upgrading your own self and university ranking.

# English Writing

- Why English?: profile building, distinguish from postgraduate students, broaden our horizons, etc.
- Grammar check
- Keep it simple: make full use of table, figure, etc.
- Clear outline: introduction, literature review, methodology, results/findings, conclusion, and references
- Length: usually 10-15 pages

- Factors should be considered:
  - organizer's credibility
  - double-blind peer-review
  - one-off conference
  - peer-reviewed proceedings

# Journal

(what issue we should aware of?)

- There are many journals both Thai and international with different rankings.
- Now, online journals are widely available.
  - More rapid, recent, and frequent than paper based.
  - BUT be ware of quality!
- Paper based journal usually takes more time than online journal. Depending on how each of following process take?:
  - Referee / Reviewer (usually takes about 3-6 months)
  - Revise Manuscript – by the author
  - Number of issue per year and paper per issue
- (Is the author(s)'s reputation and relations with editorial board important in terms of acceptance?)
- What is the special edition? Why do we have to talk about?

## 3-step instructions for submitting a manuscript (Pure Open Access)

The following is a simplification of the submission process. Each journal webpage hosts Instructions for Authors in detail. To go directly to an open access journal's web page, click the *View journal* link above. The Instructions for Authors are tabbed in the left-hand navigation bar.

1. Choose your journal via the *View journal* link.
2. Use the *Submit online* or *Instructions for authors* link on the journal web page OR go directly to each journal's submission site via the *Submit a manuscript* feature above.
3. Simply follow the instructions. Please note you need to include invoice information for payment of the APC\* (article publishing charge). View [our policy on APCs and waivers](#) on our [Author Services](#) website. We also host additional [license information](#) on the [Author Services](#) website.

\*APCs vary by journal and are subject to occasional special offers. Please check the Instructions for Authors on each journal web page to confirm the current APC. Invoices are issued and licenses signed after the article has been peer-reviewed and accepted.



## 4-step instructions for submitting a manuscript (Open Select Access)

1. Choose the journal you wish to submit an article to. All journals offering the Open Select option will have the Open Select icon appearing on their journal homepage.
2. Find the *Submit online* or *Instructions for authors* link on the journal homepage under the *Authors and submissions* navigation tab.
3. Follow the submission instructions. Once accepted, you will receive an email offering you the option of making your article open access via the Open Select route. Please follow the instructions in that email.
4. The article publishing charge for an Open Select article is USD\$2,950 (£1,788 / €2,150).

# Journal Ranking


- Journal Impact factor:
  - The impact factor (IF) of an [academic journal](#) is a measure reflecting the average number of [citations](#) to recent articles published in the journal.
  - It is frequently used as a [proxy](#) for the relative importance of a journal within its field, with journals with higher impact factors deemed to be more important than those with lower ones.
- Thai Citation Index (TCI) database –by Thai Citation Index Center- provide the Thai-Journal Impact Factor.

- International Source: e.g.
  - SCImago Journal Rank (SJR indicator) (<http://www.scimagojr.com/journalrank.php>)
  - Social Sciences Citation Index-by The Thomson Reuters- Authoritative, multidisciplinary content covers over 12,000 of the highest impact journals worldwide, including Open Access journals and over 150,000 conference proceedings with the coverage in the sciences, social sciences, arts, and humanities, with coverage to 1900. (<http://thomsonreuters.com/data-citation-index/>)
  - Journal Impact Factor is from Journal Citation Report (JCR) - by Thomson ISI (Institute for Scientific Information)- The impact factor is one of these; it is a measure of the frequency with which the "average article" in a journal has been cited in a given period of time. (<http://www.sciencegateway.org/impact/>)

# SCOPUS

- Scopus is a bibliographic database containing abstracts and citations for academic journal articles.
- It covers nearly 21,000 titles from over 5,000 publishers, of which 20,000 are peer-reviewed journals in the scientific, technical, medical, and social sciences (including arts and humanities).
- It is owned by [Elsevier](#) and is available online by subscription.
- Searches in Scopus incorporate searches of scientific web pages through [Scirus](#) ( comprehensive science-specific search engine), another Elsevier product, as well as patent databases.
